As both parties were unable to agree on a mutually acceptable resolution mechanism, the Complaints Panel initiated an investigation.</li> <li>On 4 March 2025, the Complaints Panel issued a <a href="#">decision letter</a> concluding that the complaint submitted by the Complainant could not be accepted by the RSPO. Consequently, the case was closed following this decision.</li> </ul>

Swadaya Mukti Prakarsa	Labor facilities	<p>Case closed.</p> <ul style="list-style-type: none"> <li>In May 2024, a complaint was filed through the RSPO Complaints System (<a href="#">RSPO/2024/05/RR</a>). In accordance with the RSPO Complaints and Appeals Procedures, the Company and the Complainant mutually agreed to engage in bilateral discussions to address the concerns raised.</li> <li>The bilateral engagement took place from June 2024 to December 2024 and resulted in an amicable resolution of the complaint.</li> <li>As mutual understanding was achieved and an agreement was reached between the Company and the Complainant, and a summary of this resolution was submitted to the Complaints Panel for deliberation.</li> <li>Following the successful <a href="#">resolution of the matter</a>, the case was formally closed by the Complaints Panel in January 2025.</li> </ul>
Nov 2024	Rainforest Action Network (RAN)	PT Kalimantan Green Persada	Allegation of potential overlap between the company's concession and customary lands of the Long Isun community in Mahakam Ulu, East Kalimantan.	<p>Case closed.</p> <ul style="list-style-type: none"> <li>In October 2021, a <a href="#">report</a> published by Rainforest Action Network (RAN) alleged a potential overlap between the concession of First Resources' subsidiary, PT Kalimantan Green Persada (PT KGP), and the customary lands of the Long Isun community in Mahakam Ulu, East Kalimantan.</li> <li>When the report was published in 2021, First Resources had not received prior communication from RAN. However, we are pleased to announce that in 2024, the Company had the opportunity to engage directly with RAN, enabling us to provide clarification on the issue.</li> <li>Following this engagement, the company issued a <a href="#">clarification statement</a> addressing the allegation.</li> </ul>
